# D. Financial Report

## **September 2021 Operating and Construction Funds**

As of September 30, 2021, the Operating Fund revenue was \$7,594,541, and expenditures were \$7,435,302. It was noted that the expenditures include \$2 million transferred at the beginning of 2021 to the Construction Fund. The ending fund balance was \$5,931,718.

As of September 30, 2021, the Construction Fund revenue was \$2,014,950 and expenditures were \$284,311. The ending fund balance was \$9,941,044.

Motion made by Mr. Gray, seconded by Mr. Rimmer, to accept the September 2021 Operating Fund and Construction Fund reports. Motion carried unanimously.

#### E. Director's Report

## **Integrated Library System (ILS)**

The implementation process and training for the new ILS is complete, and as of October 25, Koha is the official ILS for circulation and cataloging.
